between the two institutions in education and in academic research, agree to the following:

- a. to develop joint research activities;
- b. to support mutual visits by faculty members;
- c. to exchange graduate and/or undergraduate students;
- d. to explore collaboration in education;
- e. to invite each other to participate in seminars and conference organized by the respective institution;
- f. to exchange scientific information in the form of publications, instruction materials and other results of teaching and research.

The terms of cooperation for each specific activity implemented under this cooperation agreement shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of that activity.


As both partners are aware of existing restrictions in their respective budgets, they will, as a rule not enter into financial commitments that reach beyond such limits for each item of this cooperation. Therefore, financial aspects shall also be regulated on a case-by-case basis as mentioned at a. to f. above.

Each institution shall designate a liaison officer to develop and coordinate the specific activities agreed upon.

This cooperation agreement shall become effective for an initial period of five years from the date when the representatives of both universities affix their signatures to it.


