

STUDENT EXCHANGE AGREEMENT BETWEEN THE GRADUATE INSTITUTE OF INTERNATIONAL AND DEVELOPMENT STUDIES, GENEVA, AND EL COLEGIO DE MEXICO.

This Agreement for Student Exchange (hereinafter referred to as "Agreement") is made pursuant to the Memorandum of Understanding for the purpose of promoting academic cooperation in the field of international studies. The two institutions hereby agree that:

1. The exchange program is open to students regularly enrolled in the partner institution at the Master's and Doctorate level.
2. Students are selected by the home institution in a way that guarantees their capacity to follow the courses offered at the same level by the partner institution. The host institution takes the final decision on the basis of the academic record of the exchange student and in accordance with its own language and any other requirements.
3. Each institution will accept up to two students for exchange each year from among those proposed by the partner institution. This number may vary in any given year provided a balance of exchanges is attained over the term of the Agreement.
4. The normal period of exchange shall, in principle, be one semester for Master students and a maximum of two semesters for Doctorate students.
5. Students accepted for exchange will be enrolled as non-degree full-time students and will have access to all courses relevant to their program of study. The academic results and the corresponding credits transferred will be communicated to the home institution.
6. The name of the exchange institution and the number of credits obtained during the exchange program may be annexed to on the final transcript/diploma of the student.
7. Each institution will ensure that the exchange students shall receive full support from its Students' Office and benefit from the same rights and advantages as its regular students.
8. Exchange students will pay tuition fees and other fees, if any, to their home institution.
9. All other costs – expenses associated with travel, room, board, study materials, local transportation, student health insurance, medical care, personal matters and passport/visa applications – are incumbent to the exchange students themselves.
10. The exchange program shall be administered through the Coordinator at the Graduate Institute, Geneva, and through the Coordinator at El Colegio de Mexico. All information necessary to the implementation of the exchange program (academic schedule, course

catalogue, etc.) will be sent to the partner institution.

11. This Agreement will be effective from the date of signature and shall remain valid for an initial period of three years. Thereafter, it shall be automatically renewed each year, unless any party serves a written notice to terminate the Agreement at least 6 months prior to the expiration date. The terms of this Agreement may be revised and modified through mutual discussion and consent between the two institutions.

Either institution may at any time terminate the Agreement by giving a written notice six months prior to the intended time of termination.

This Agreement is written in English in two copies, both are equally authentic. As witness to their consent to this Agreement, the appropriate authorities hereunto affix their signatures.


