AGREEMENT ON ACADEMIC LINKAGE AND COLLABORATION

Article 1

The Faculty of International and Political Studies of the Jagiellonian University in Kraków and El Colegio de México, wishing to promote cooperation between the two institutions in education and academic research, agree to the following:

- a. to develop joint research activities;
- b. to support mutual visits by faculty members;
- to exchange graduate and/or undergraduate students;
- d. to explore further possibilities of collaboration in education;
- e. to invite each other to participate in seminars, lectures, and conferences organized by the respective institutions;
- f. to exchange, in accordance with applicable legal regulations, scientific information in the form of publications, instruction materials, and other results of teaching and research.

Article 2

In order to execute joint activities specified in Article 1, the Parties to this Agreement shall enter detailed agreements regulating, at least, the scope of joint actions, rights and obligations of the Parties, financing regulations of these tasks, and persons responsible for conducting and coordinating tasks arising from this Agreement.



Article 3

In order to execute this Agreement in an efficient manner, the Parties appoint as their representatives:

Jagiellonian University, Faculty of International and Political Studies: Dr. Marta Kania

El Colegio de México:

Article 4

- 1. This Agreement shall become effective on the day of signing by representatives of both Parties.
- 2. This Agreement shall become effective for an initial period of 5 (five) years. The Agreement may be prolonged for a period specified by the Parties in their mutual agreement.
- 3. The Agreement may be terminated by each Party in writing, under pain of nullity, in compliance with the notice period of 12 months, effective as at the end of the academic year. The Agreement may be terminated at any time by mutual agreement of the Parties.
- 4. In the event of termination of this Agreement, in accordance with paragraph 3, the Parties shall specify regulations concerning continuation or termination of detailed agreements, referred to in paragraph 2, whose term shall end after the date of termination of this Agreement.

Article 5

- 1. Any amendments to this Agreements shall be made in writing, under pain of nullity.
- 2. This Agreement has been drawn up in six copies in three language versions, of which two copies are in Polish, two copies are in English, and two copies are in Spanish; one copy in each language for each Party. The Parties agree that in the event of any conflict between the versions, the provisions of the English version shall prevail.
