**Agreement on Academic Exchange
between
El Colegio de México
and
Osaka School of International Public Policy
Graduate School of Economics
Osaka University**

The President of El Colegio de México and the Deans of the Osaka School of International Public Policy and the Graduate School of Economics, Osaka University, Japan, with the objective of promoting cooperation in the fields of education and academic research, agree to conclude the following agreement on academic exchange.

Article 1

Both institutions agree to promote the following activities so as to enhance their educational and academic research in the necessary fields:

- (1) Activities such as collaborative research, lectures, symposiums, etc., and the exchange of researchers pertaining thereto;
- (2) The exchange of information and materials in those fields, which are of interest to both parties;
- (3) The exchange of graduate students.

Article 2

Specific matters pertaining to the implementation of the exchanges based on this agreement shall be negotiated and agreed upon between both institutions concerned in each specific case and may be stipulated in writing as memorandums complementary to this agreement.

Article 3

Both institutions shall try to resolve any matters arising from activities between parties concerned amicably.

Article 4

This agreement shall become effective on the date of its signing by the representatives of both institutions and shall be in force for five years.

Article 5

This agreement is subject to revisions by mutual written consent.

Article 6

Either institution may, by giving a six-month written notice to the other institution, terminate the agreement. However, the termination of this agreement shall not affect the implementation of the collaborative activities established under it prior to such termination.


Article 7

In the absence of any such early termination, the renewal of this agreement shall be discussed by the two institutions at least 6 months prior to the natural termination of the current agreement.

This agreement is to be executed in English and each party shall retain an original copy.
