

ADDENDUM TO THE
AGREEMENT ON ACADEMIC LINKAGE AND COLLABORATION
FOR STUDENT EXCHANGE

between

HANKUK UNIVERSITY OF FOREIGN STUDIES

and

EL COLEGIO DE MÉXICO, A. C.

Purpose

Hankuk University of Foreign Studies and El Colegio de México, A. C. agree to enter into the following clauses concerning the exchange of students in order to promote education and mutual understanding at an international level.

Number of Exchange Students


Every academic year, each institution will offer up to **2 semester spots or 1 full-year spot**. The decision to nominate the students for one semester or one year, as well as the spot's distribution, lies in the home institution.

Selection of Exchange Students

Each institution will select its own students based on its own requirements. Nevertheless, the host institution will make the final decision on admission for the chosen student(s).

Besides taking into consideration its own requirements, the home institution should also consider the host institution's requirements:

- When El Colegio de México is the host institution, Hankuk University of Foreign Studies students are required to present a **Spanish language certificate** with a minimum of C1 level (DELE) or equivalent - an official certificate of the home institution is also valid, only when proper stamp and signature are included; students must hold a **GPA** of at least 8 on a scale of 0 to 10 at all times (or its equivalent) when applying.
- When Hankuk University of Foreign Studies is the host institution, El Colegio de México students are required to present an English language certificate with a minimum of TOEFL IBT Score 80 or equivalent - an official certificate of the home institution is also valid, only when proper stamp and signature are included; students must hold a GPA of at least 2.5 on a scale of 4.0 at all times (or its equivalent) when applying.



Rights and Duties of Exchange Students

Exchange students will be subject to the laws of the host country, as well as the regulations of the host institution. They shall enjoy the same rights as the rest of regular students of the host institution.

Expenses

Both institutions shall exempt exchange students from any academic fees.

Housing

The host institution will assist the exchange student to find adequate accommodation but it is not in charge of it. The cost of accommodation and contractual relationship with the landlord shall be responsibility of the student.

Health Insurance

It is responsibility of exchange students to hold a health insurance.

Diploma and Evaluation

Both institutions agree to issue a certificate of attendance and the corresponding academic transcript at the end of the course.

Tutoring

Both institutions shall clearly identify the offices and tutors responsible for providing personal assistance to the exchange student.


Modification

Any necessary modification in this Addendum to the clauses concerning student exchange will be solved upon mutual agreement between the parties.

Duration

This Addendum will be valid for a period of five (5) years. At the end of five years, the agreement will automatically be renewed unless otherwise indicated.


